

# Privacy policy regarding the processing of personal data on the site www.aurofin.ch

Pursuant to the Federal Act on Data Protection ("FADP"), we provide you with the necessary information regarding the processing of personal data collected during your experience on our site <a href="https://www.aurofin.ch">www.aurofin.ch</a>.



### 1. CATEGORIES OF PERSONAL DATA SUBJECT TO PROCESSING | DEFINITIONS

Personal data provided by you – or otherwise acquired in accordance with applicable legal and contractual provisions – inherent in, connected with and/or instrumental to the evaluation of your experience on our site, will be processed in accordance with the privacy legislation and confidentiality obligations applicable to you.

Personal data: all information relating to an identified or identifiable person.

In particular, we will process the following personal data:

browsing data (for more information on the data collected with Cookies, please read the Cookie Policy which can be found here: COOKIE POLICY).

Please note that the computer systems used to operate this site acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. This category of data includes the IP addresses or domain names of the computers and terminals used by users, the URI/URL (Uniform Resource Identifier/Locator) notation addresses of the resources requested, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the user's operating system and IT environment.

Data subjects: natural persons whose data is processed.

**Processing**: any operation concerning personal data, regardless of the means and procedures adopted, and in particular the collection, storage, use, revision, communication, archiving or destruction of data.

**Communication**: the act of making personal data accessible, for example by authorisation of consultation, transmission or disclosure.

#### 3.1 DATA PROCESSING METHODS

The processing will be carried out in automated and/or manual form, using methods and tools designed to ensure maximum security and confidentiality, by specially trained persons. The personal data collected will be stored in a form that enables the identification of the data subjects for a period of time not exceeding the purposes for which the personal data are processed.

#### 4. RECIPIENTS OF PERSONAL DATA

We may share personal information with employees and/or staff acting under the authority of the Data Controller (duly instructed to do so), as well as third parties bound to the Data Controller by a contractual relationship, for the purpose of fulfilling contractual obligations and fulfilling one or more of the aforementioned processing purposes. These third parties will process the data provided as Data Processors or independent Data Controllers. Specifically, we may share the personal data collected with the following categories of recipients:

- a) parties providing services related to the operation of this website (e.g. hosting providers);
- b) support and consultancy companies (e.g. web & digital marketing agencies);
- authorities responsible for compliance with legal obligations and/or provisions of public authorities, upon request.



#### 5. TRANSMISSION OF PERSONAL DATA OUTSIDE THE SWISS CONFEDERATION

The site is based in Switzerland (hosting), so data will not be transmitted outside the Swiss Confederation



#### 6. RIGHTS OF THE DATA SUBJECT

Pursuant to the FADP, the Data controller grants you, as Data Subject, the following rights (non-exhaustive list):

- obtain the rectification of inaccurate or obsolete personal data.
- be informed in writing and free of charge whether personal data concerning him/her are being processed
- preventing the communication of any sensitive personal data to third parties.
- obtain the portability of personal data or request that they be transferred to third parties.
- request the restriction or blocking of data processing, the prevention of disclosure of data to third parties, or the rectification or destruction of personal data.
- request the prohibition of specific processing of personal data and specific communication of personal data to third parties or the deletion or destruction of specific personal data.
- if neither the correctness nor the inaccuracy of the personal data can be proved, request the addition of a note to indicate the objection.
- require that the rectification, destruction, blocking, especially the communication to third parties, as well as the notice of challenge or judgement be communicated to third parties or published.
- have the processing of personal data declared unlawful.

Without prejudice to any other administrative and jurisdictional recourse, if you consider that the processing of your data violates the provisions of the FADP, you have the right to notify a complaint with the competent supervisory Swiss authority, namely to the Federal Data Protection and Information Commissioner.

It is understood that you may exercise your rights by contacting the Data controller by writing to the above-mentioned addresses.
